give the Registrant a written or by e-mailed notice by setting a deadline of fifteen (15) days following the receipt of the notice, to explain in writing cause(s) of the breach. TWNIC may suspend or cancel, depending on the character of the breach, the domain name registration of the Registrant, or take other reasonable measure, if the Registrant fails to submit acceptable grounds in writing along with necessary evidences or to correct the breach within such deadline.

In the event that the Registrant has breached this Domain Name Registration Agreement for a plurality of times, all based on the same domain name, TWNIC may request the Registrant to respond in writing within a specified period of time.

For the avoidance of doubt, the Registrant hereby acknowledges and agrees that regarding the periods of time set forth under the preceding three Sections,

give the Registrant a written or by e-mailed notice by setting a deadline of thirty (30) days following the receipt of the notice, to explain in writing cause(s) of the breach. TWNIC may suspend or cancel, depending on the character of the breach, the domain name registration of the Registrant, or take other reasonable measure, if the Registrant fails to submit acceptable grounds in writing along with necessary evidences or to correct the breach within such deadline.

In the event that the Registrant has breached this Domain Name Registration Agreement for a plurality of times, all based on the same domain name, TWNIC may shorten the deadline of the preceding Section 2 to fifteen (15) days or seven (7) days, for the Registrant to respond in written.

Failure by TWNIC to take prompt measures with respect to a fact of breach by the Registrant shall not be deemed evidence that
